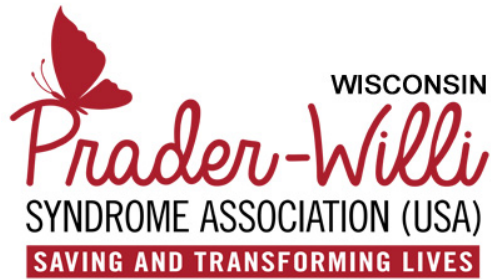


2021 PWSA of Wisconsin, Inc. Annual Report

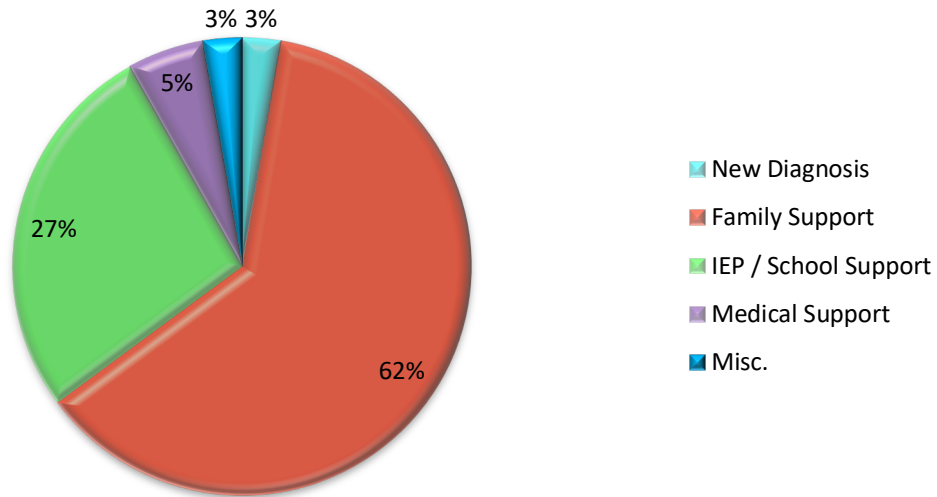


149 people participated in three **Family Virtual Bingo Bashes**.
